

Israeli– Palestinian Conflict: Who is the Peace Breaker?

The ongoing struggle between Israelis and Palestinians has again recently generated global attention due to a ground invasion led by the Israel Defense Forces against Hamas in the Gaza Strip. According to the Gaza Health Ministry, as a result of this relentless violence between these two sides, 732 Palestinians have been killed, including at least 166 children. More than 4,600 people have been wounded. Thirty-two Israeli soldiers and 3 civilians have been killed as well.

Who should be blamed for preventing this area for decades from being peaceful and stable? While the Israeli military continues its massive ground offensive in the Gaza Strip in the name of protecting its people from the terror attacks led by Hamas, hundreds of thousands of people in

many places throughout the world have gathered to chant anti-Israel slogans. This tense atmosphere against Israel has lit a fire for the movement against the U.S. which has given full support to the Israel-led campaigns in Gaza.

Did You Know...BRICS' New Development Bank

Leaders of the so-called BRICS (Brazil, Russia, India, China, and South Africa) recently announced the creation of the New Development Bank (NDB), which will finance "sustainable development" projects in developing countries, and the Contingent Reserve Arrangement (CRA), a reserve for members in crisis. Though the initial capital reserves of the NDB and CRA are nothing near the size of the World Bank or IMF, analysts are calling these new institutions a direct challenge to the U.S. and EU-dominated world financial order.



However, other analysts contend that while the NDB may offer an opportunity for developing countries to have a greater voice in international finance and access to development

assistance without the harmful stipulations attached to IMF lending, the power shift may translate into dominance by China. As the largest economy by far among the five, China could certainly hold tremendous sway over future decisions. However, this remains to be seen.


